THE ORGANIZATION DEDICATES AN ABUNDANCE OF TIME AND RESOURCES TO STRENGTHENING AND PROTECTING THREATENED INTERSCHOLASTIC/INTERCOLLEGIATE WRESTLING PROGRAMS AND ESTABLISHING NEW PROGRAMS. SINCE 2001, THE NWCA HAS HELPED TO ESTABLISH OVER 250 NEW COLLEGE WRESTLING PROGRAMS AT ALL LEVELS (INCLUDING 76 WOMEN'S INTERCOLLEGIATE TEAMS).
